Most of the affordable housing listed is for people with low and moderate incomes. Low income is defined as at or below 50 percent of median family income. Moderate income is over 50 percent, but no more than 80 percent of median family income. Some are for those with " very low " incomes, at or below 30 percent of median county income.

Elderly/handicapped public housing: To be eligible for state-aided elderly/handicapped public housing, an applicant must be low income and be age 60 or over, or if less than 60 years of age, must have a qualifying disability. The IRC §42 Low Income Housing Credit Program was enacted by Congress as part of the Tax Reform Act of 1986 to encourage new construction and rehabilitation of existing buildings as low-income rental housing for households with income at or below specified income levels.

IRC §42, Low-Income Housing Credit

Low income housing created through the LIHTC program are required to remain affordable for 15 years, though in practice many agreements extend for 30 or more years. By law, a Federally funded low income housing project (including LIHTC) may not refuse to rent to a Section 8 voucher holder.
